

## Car raffle terms and conditions 2025

- 1. This raffle is being promoted by and on behalf of the Children's Health Foundation (the Foundation), CHY 13534 RCN 20042462 CRO 328920.
- 2. By entering the draw, participants agree to be bound by these terms and conditions.
- 3. The draw closes for entries at 23:59 on 25<sup>th</sup> August 2025. All entries must be received by this time and no later.
- 4. The draw will take place on 28th August 2025.
- 5. To enter the draw a ticket (or tickets) must be purchased.
- 6. The winner of the draw will be chosen at random from all entries received by the closing date.
- 7. There is two prizes available to be won in the draw:
  - 1. A brand-new car.
  - 2. A seller's prize of €500 for selling a whole book of tickets.
- 8. No cash alternative is available.
- 9. Your chances of winning are variable, depending on how many tickets are purchased for the raffle as a whole. Your winning odds are the number of tickets you have purchased divided by the total number of tickets in the draw.
- 10. The raffle is open to all adults who are aged 18 (eighteen) or over on the date of ticket purchase, (except for employees of Children's Health Foundation).
- 11. Any person found to be under 18 (eighteen) years of age on the date of ticket purchase automatically forfeits the right to the prize.
- 12. You must be 18 (eighteen) or over to claim a prize.
- 13. The winner may need to provide proof of age before collecting the prize. Acceptable documentation of the winner's proof of age will be a scan of their passport or driving license.
- 14. Tickets to enter the draw are priced at €3 each and can be bought individually or in ticket bundles from sellers. You may call 1800 211 785 if you wish to have a ticket booklet sent out to you.
- 15. All draw entry sales are final. Refunds are at the sole discretion of the Foundation and will be payable only where the Foundation deems it reasonable, having regard for all the circumstances. All participants acknowledge that their payment of the ticket price does not guarantee that they will win a prize.
- 16. Only tickets for which full payment has been received are eligible to win the prize.
- 17. Winners of the raffle prize will be contacted by the Foundation within seven working days of the draw taking place. Details of the winning ticket numbers will also be posted on our website.
- 18. All participants are solely responsible for providing and (where necessary) updating the Foundation with their accurate and up-to-date contact details and the Foundation will be in no way liable for any failure or inability to contact any participant due to any errors, omissions or inaccuracies in the contact details that the participant has provided on the ticket stub.
- 19. The Foundation shall not be liable to any participant for any loss or damage suffered or arising from:



- 1. any delays or failures in the delivery methods used by the Foundation or the participant;
- 2. any delays or failures in any software or other systems used by the Foundation for the administration of the draw;
- 3. any delays or failures in the banking system used by the Foundation or the participant;
- 4. any refusal by the Foundation to accept an individual's entry or the cancellation of an entry;
- 5. any event beyond the reasonable control of the Foundation.
